Report: Short-term certificate course on Digital Marketing

In association with Allsoft Solutions, Business Partner IBM, skill development course on Digital Marketing was organized in in the college. Classes of duration one to one and half an hour (duration varied for three different batches) for this 50-hour course started on 20th September 2019 and conducted till 14 December 2019 with break in between for mid semester test. A certified trainer from Allsoft, Mr. Yatharth conducted the course. Forty-four (44) students opted for the course. 



In order to broaden the knowledge base of the students and provide them practical exposure, certificate courses offered by institute of repute are being identified. Out of the so far identified courses, <u>Certificate Course on Equity Portfolio Management</u> is proposed to be introduced in the College.

Report

Certificate Course on Equity Portfolio Management

The College signed MOU with ALPHABETA INC (which has its collaboration with 'National Stock Exchange Academy') to introduce a course on 'Equity Portfolio Management'. This course provided a practical introduction to equity portfolio management. Using an interactive app, the learning was driven by simulation techniques that allowed the learners to visualize stocks, understand concepts, make decisions, and create trades like a portfolio manager.

Course Fee

The original course fee was 23,600 INR for this course which had been negotiated to 8,000/-INR.

Participants for the Course

In order to invite the students to attend this course, a google link was created and circulated to all the students. 16 students and 1 member from the teaching faculty registered themselves for this course.

Duration

Each session was for 90 mins, one per week, through audio/video conference using via Zoom Application. In total, there were 6 mentored sessions. The programme had its first session on 25th January 2020 and last session on 7th March 2020.

As a part of this journey, the participants were provided with the access to:

- Mentored Online sessions Access to "Live" mentored sessions, where ALPHABETA accredited faculty discussed the trading strategies and attempted to resolve participants queries.
- NCFM Certification At the end of online sessions, participants who have successfully completed the course requirements (assignments, presentations, Manage positions, etc.) will received a joint certification from NSE Academy and ALPHABETA Inc. 50% weightage was given to individual written assignments, 25% for class participation and presentations and a further 25% for Leaderboard ranking (Manage positions). A minimum of 20% overall was required for the completion certificate. 80% and above was counted as grade A, 50-70% as B and 20-40% as C.

 ALPHABETA Guide App – The participants had been given Lifetime access to the Learn and Simulate modes of the platform. The Learn module of the app provided the participants access to lab experiments, video lectures, research papers on all the strategies which the participants learnt in this course. The Simulate module of the app, allowed to back test these strategies over the last 9 years. The access became active from the date of the commencement of the program. 52 weeks / One year access to Manage Mode of the platform. The Manage mode, enabled the participants to manage portfolios in near-real time, with real market data.

Assignments: At the end of self-study during week 1 for each module - written assignment had to be submitted, before participants come to attend the mentor session. During the course, the participants had 3 such assignments, after Momentum, Value/ Accrual and Pairs. The participants were required to perform Lab Experiments on the ALPHABETA app (under each strategy) and record their learnings and performance.

Presentations: After some modules were completed, a presentation that had to be prepared and discussed with the ALPHABETA expert panel. The first one has to be presented on the 22nd February 2020 (Momentum and Value/ Accrual), the next on 7th March 2020 (Pairs Trading).
