FINANCIAL SUPPORT TO STUDENTS

SCHOLARSHIP SCHEME INSTITUTED BY THE COLLEGE TRUST FOR STUDENTS BELONGING TO ECONOMICALLY WEAKER FAMILIES

The College Trust has instituted a scholarship scheme for the students coming from economically weaker families. The scholarship will be granted to the eligible students @ 50% of the College Fees including fee for Special Facilities but excluding University charges. The details of this scheme are as follows:

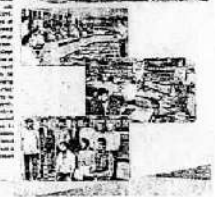
OTHER SCHOLARSHIPS AND FEE CONCESSIONS OFFERED BY THE COLLEGE
